


# 1. INTRODUCTION THE CISM SPORT CLIMBING

The International Military Sports Council, known by its acronym "CISM", is an international sports association composed of the armed forces of member nations accepted by the General Assembly. CISM is open to the armed forces of all nations.

The fundamental aim of CISM is to promote sport activity and physical education between armed forces as a means to foster world peace. This ideal is encapsulated in the CISM motto "FRIENDSHIP THROUGH SPORT".

Sport climbing has been part of the CISM sports since 2010 when sport climbing was included in the Military World Winter Games program. At the Games, the first tournament was held from 21 to 22 March 2010 in Italy where 45 athletes (men and women) competed in the discipline "lead". The next competition was held in France in 2013. In 2017, the tournament was organized by Russia. It was held in Sochi from 24 to 27 February. Seventy (70) athletes from Russia, Spain, Belgium, Slovenia, Italy, Austria, Germany, France, Switzerland and Kazakhstan fought for the medals. The most impressive number of awards were played during this tournament. Participants competed in bouldering, lead and 2 types of speed - classic and record.

The first Military World Championship in sport climbing was held in 2018. Athletes competed in Moscow in the CSKA sports complex from 28 November to 2 December. 33 athletes from Russia, Switzerland, Austria, Spain, Kazakhstan and Slovenia participated in the tournament.





# 2. SPECIFIC REGULATIONS FOR CLIMBING

# 1. ORGANIZATION OF CISM SPORT CLIMBING COMPETITION

- **1.1.** The Sport Climbing championship is, in principle, organised annually, under the auspices of the International Military Sports Council (CISM).
- **1.2.** The championship should be planned preferably in harmonization with the International Federation of Sport Climbing (IFSC) Calendar.
- **1.3.** The levels of CISM sports climbing competitions are:

World Games / World Championships, Continental Games / Continental Championships, Regional championships / Tournaments, Bilateral competitions.

**1.4.** The regulations for the organization of the particular level of competition are elaborated in the CISM Regulations, Chapter VII.

#### 2. RULES

**2.1.** The Championship will technically be organised according to the latest IFSC rules, inclusive of the accepted changes. Rules could be found at:

## 2.2. DISCIPLINES

CISM sport climbing competitions shall include the following Disciplines:

- A) **Lead**: Competitors are ranked based on their progression on one or two routes.
- B) **Bouldering**: Competitors are ranked based on the number of boulders completed.
- C) **Speed**: Competitors are ranked based on the time needed to climb a standard route.
- D) **Combined**: Competitors are ranked based on their overall performance across two rounds: boulder and lead in that order.
- E) Other disciplines authorised by the CISM (e.g. Speed classic format, Team). Rules of such disciplines have to be included in the Invitation.
- **2.3.** Each Championship shall include Male and Female Categories for each aforementioned Discipline.
- **2.4.** The organizer of the CISM sport climbing competition has to stipulate in the Invitation file which aforementioned disciplines will be carried out at the pertaining competition.

#### 3. COMPOSITION OF THE MISSION

3.1. Recommended composition of the mission shall be based on the number of participating climbers per the following chart:

Chief of Mission	
Team Captain	
Coaches	2
A person that is up to national choice (e.g. doctor, physiotherapist, etc.)	
Athletes - male	6
Athletes - female	6

**3.2.** The final composition of the mission has to be part of the Invitation file. A number of athletes can be set for each Category with a maximum of six (6) athletes per Category.





- **3.3.** All athletes must be military personnel on full active duty in the Armed Forces of their respective nations. Participation of inactive member nations is not authorized. All of the participants are asked to present the following documents upon registration: Military ID card, Personal identification card or Passport.
- **3.4.** Whenever the CISM para sport climbing competition is organized, the composition of the mission for para-climbing shall be additionally specified in the Invitation file.

#### 4. NATIONAL TEAM RANKING

- **4.1.** Following the completion of the Final round of each individual event, the first thirty competitors in each Category and Discipline (i.e. lead, bouldering and speed) shall be awarded the Ranking Points for the purpose of calculating the "National Team Ranking:"
- **4.2.** Team Ranking shall be calculated by adding the Ranking Points of the six (6) highest-ranked team members in each Category for each discipline. Teams are ranking in descending order of the total number of Ranking Points accumulated.
- **4.3.** Ranking Points for the purpose of calculating the National Team Ranking of each competitor are as follows:

Note: The Ranking Points gained by tied competitors will be the average of the points for the tied rank positions. The points will be rounded down to two (2) decimal places. (For instance: three (3) competitors took 11th place. The average points of those competitors are (31 + 28 + 26)/3 = 28.33).



#### 5. ANTI-DOPING

- **5.1.** Anti-Doping tests have to be conducted in accordance with the CISM Regulations Chapter IX, CISM Anti-Doping Rules, the concerned CISM Sports Regulations, the concerned International Federation Rules, and all WADA rules, mainly the World Anti-Doping Code, and the International Standard for Testing.
- **5.2.** The number and type of tests, as well as the athletes to be tested, shall be determined by the CISM Anti-Doping Commission. These procedures will follow the concerned CISM Test Distribution Plain (TDP). In case an athlete has a Therapeutic Use Exemption (TUE), the Chief of Delegation should send this TUE to the CISM GS 30 days before the Opening Ceremony. This TUE will be submitted to the TUE Commission for analysis and further approval.

## 6. CISM PARA SPORT CLIMBING

- **6.1.** The CISM para sport climbing competitions will technically be organised according to the latest IFSC para classification and the competition rules.
- **6.2.** Any peculiarities concerning the CISM para sport climbing competition have to be specified in the Invitation letter.
